Safety Notes

The Xerox DocuColor 12 copier/printer and the Document Centre ColorSeries 50 and the recommended maintenance supplies have been designed and tested to meet strict safety requirements. Attention to the following notes will ensure the continued safe operation of your copier/printer.

Electrical safety

- Use only the power cord supplied with this equipment.
- Plug the power cord directly into a correctly grounded electrical outlet. Do *not* use an extension cord. If you do not know whether or not an outlet is grounded, consult a qualified electrician
- Do not use a ground adapter plug to connect this equipment to an electrical outlet that lacks a ground connection terminal.



WARNING: You may get a severe electrical shock if the outlet is not correctly grounded.

- Do not place the copier/printer where people may step on or trip on the power cord. Do not place objects on the power cord.
- Do not override or disable electrical or mechanical interlocks.
- Do not obstruct the ventilation openings. These openings are provided to prevent overheating of the machine.

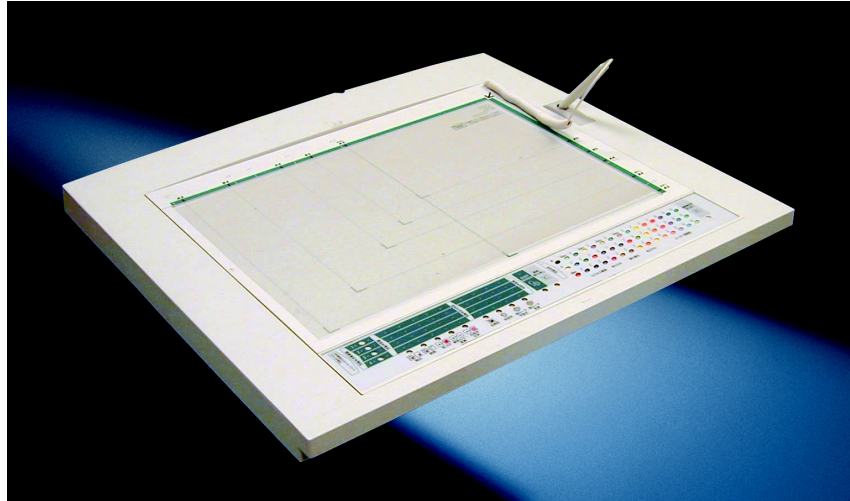

The Edit Pad is an optional accessory for your DocuColor 12 copier/ printer or Document Centre ColorSeries 50. Use the Edit Pad features when you want to add, delete, or change parts of the original document before copying.

The 1, 2, 3 symbol indicates the beginning of a procedure. Be sure to follow steps carefully in the order given.

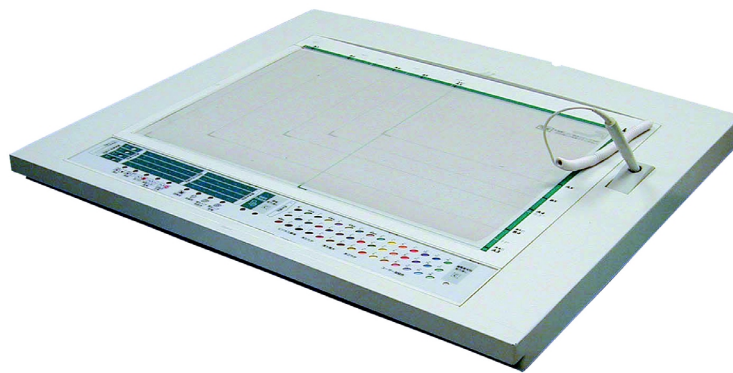

2. Getting to Know Your Edit Pad



Overview

This chapter provides an introduction to the copier/printer Edit Pad applications and Edit Pad components and shows an example of how to use the Edit Pad features.



NOTE: Some graphics may not appear in the manual exactly as they would appear after actual copying.

Edit Pad Features

The copier/printer Edit Pad has a variety of features to help you edit original documents. You can take black and white originals and colorize them, highlight areas of an original for emphasis, or delete unwanted text or graphics from your original. Sample graphics of images altered using the Edit Pad are found on the following pages.

The edit features included with the copier/printer Edit Pad are:

- **Erase Outside:** Deletes the portion of an original document located outside a boundary
- **Erase Inside:** Deletes the portion of an original document located inside a boundary
- **Highlight:** Colorizes the background of a selected portion of an original document without changing the text
- **Color Conversion:** Changes the color of image such as text or illustrations within a boundary
- **Negative Image:** Changes areas within the boundary from light to dark or from dark to light

Enhancing documents with

Erase Outside and Erase Inside

Use the **Erase Outside** and **Erase Inside** features to edit unwanted text or graphics from your documents. The edited samples displayed below show unwanted text edited out of original documents.

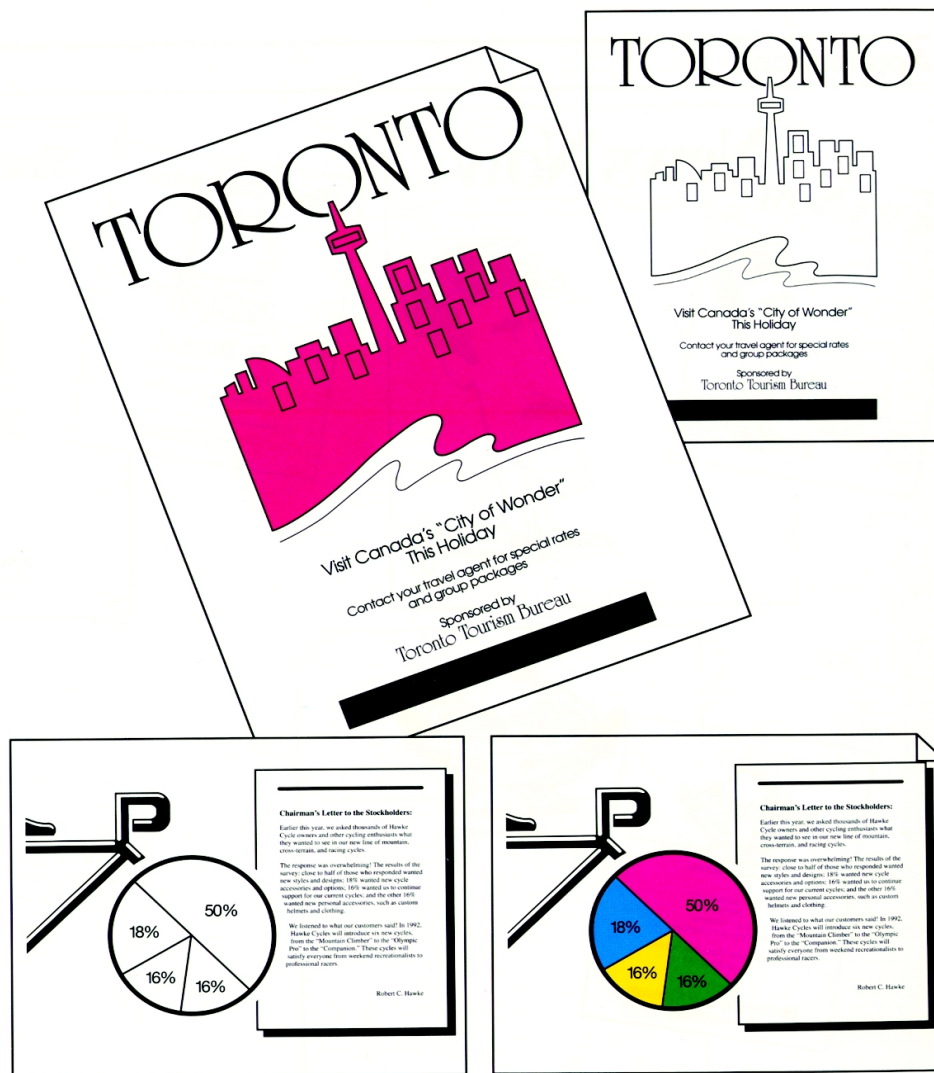

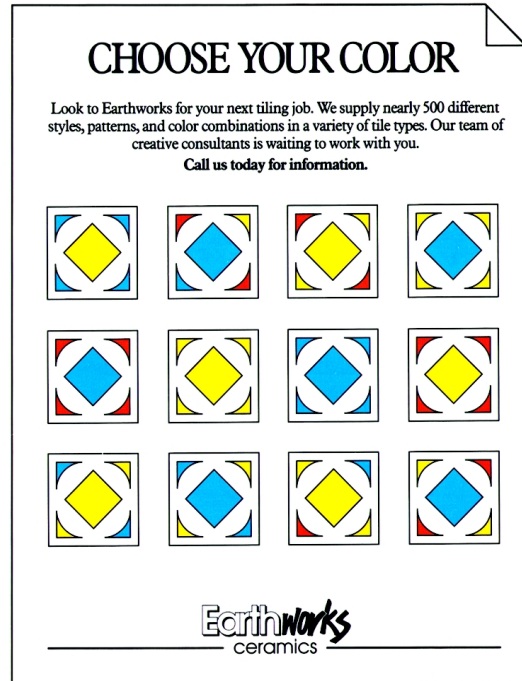
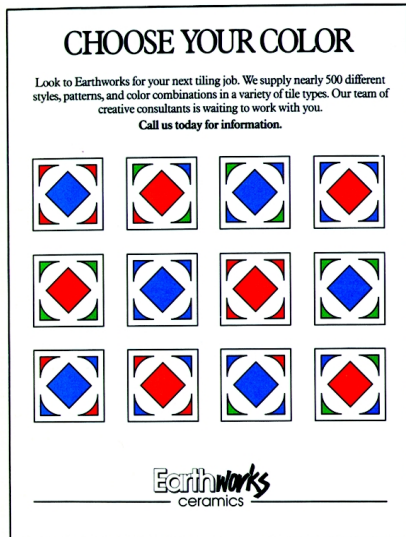
To make your copies visually appealing, add highlight colors to the background.

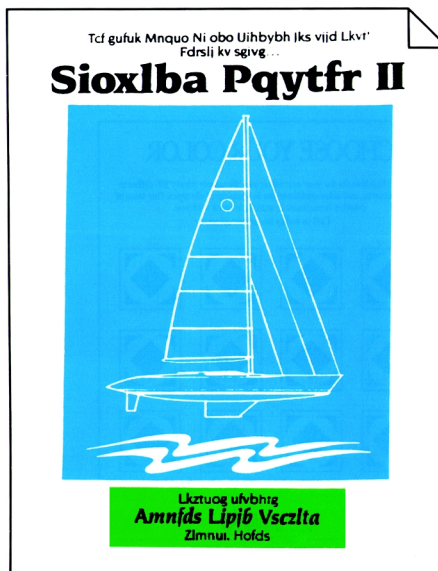
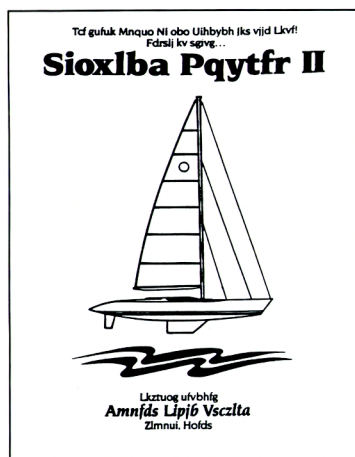
Color Conversion

Add special effects to your copies by changing one or more colors to other colors.



Using Negative Image to change colors

Change the appearance of your copies by changing dark or colored text. The graphic displayed below shows a negative image of the sailboat and text. In the edited document, background color has been added using the Color Conversion feature.

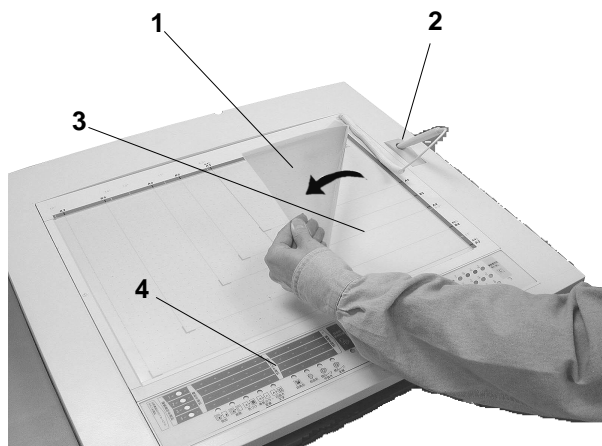


Key components of the Edit Pad

Use the optional Edit Pad to select points or areas on a document where you want to apply the features available with the Edit Pad.

The key components of the Edit Pad are identified in the illustration and list below:

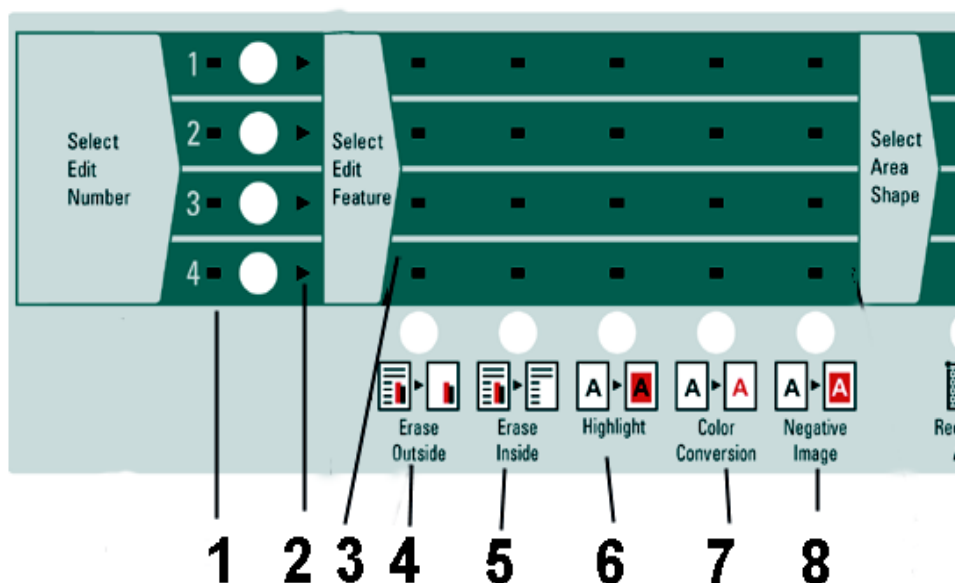
1. A clear plastic overlay is used to protect your original document
2. An Edit Pen is used to select areas of your original
3. A work surface is used to position your originals
4. An Edit Pad Control Panel and Color Palette allow you to select features
5. The copier/printer Control Panel allows you to select features



NOTE: The copier/printer Touch Screen provides options, instructions, and System Administration tools to help you use the Edit Pad effectively.

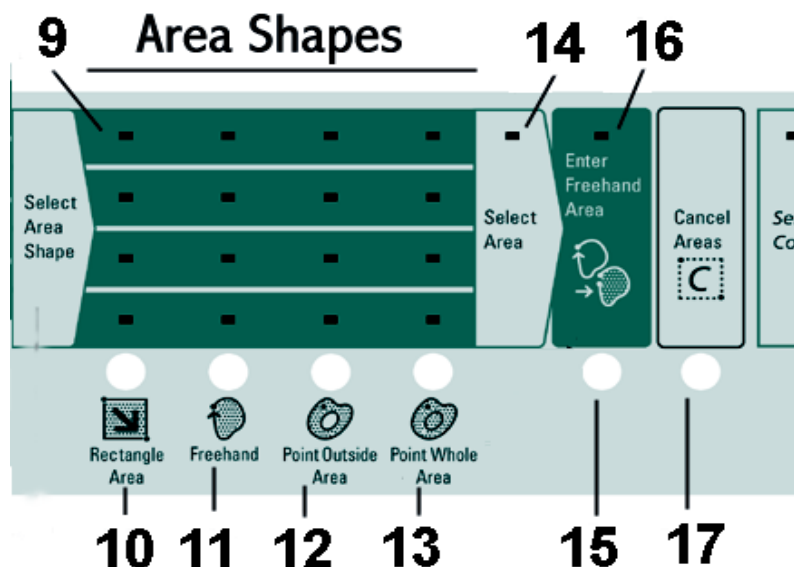
The following illustration and table show and define the various **Edit Pad Control Panel** and **Edit Number** features:

Edit Feature Selection



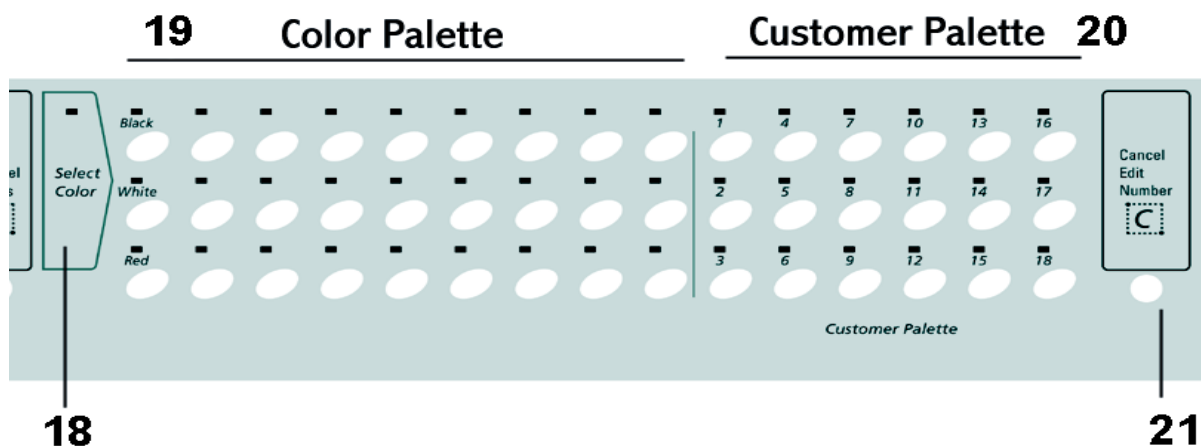
Call-out No.	Name	Function
1	Select Edit Number indicator	These indicators flash to inform you that you must select an Edit Number . One of these indicators lights after you select an Edit Number . If you select a different Edit Number , the corresponding indicator lights and the previous indicator switches off.
2	Select Edit Number arrow indicator	Once you select an Edit Number, the corresponding Edit Number indicator (2) flashes. An Edit Number must be active for you to cancel any selections.
3	Select Edit Feature indicators	These indicators flash to inform you that the features can be selected. When a feature is selected, that particular indicator light and all other indicators switch off.
4	Erase Outside	Use this feature to delete images outside a selected area.
5	Erase Inside	Use this feature to delete images inside a selected area.
6	Highlight	Use this feature to add a background color to apply color to the area selected. Black text or images in the colored area remain visible on the copy as long as the Highlight color is a different hue.
7	Color Conversion	Use this feature to convert all images in a selected area, including text, to a selected color.
8	Negative Image	Use this feature to convert the background in a selected area or text to its appropriate negative counterpart.

The following illustration and table describe the **Area Shapes**, **Select Area**, and **Cancel Areas** features on the Edit Pad Control Panel:



Call-out No.	Name	Function
9	Select Area Shape indicators	These indicators flash when you must select an area type. When you select an area type, only that specific indicator remains lit.
10	Rectangle Area	Use this feature to specify an area by using the Edit Pen to point to opposite corners of a rectangle.
11	Freehand	Use this feature to define an area by drawing an outline around the area with the Edit Pen , or by making a series of points around the desired shape.
12	Point Outside Area	Use this feature to specify an area by using the Edit Pen to define a closed area between two boundaries.
13	Point Whole Area	Use this feature to specify an area by using the Edit Pen to define an entire area within a boundary.
14	Select Area indicator	This indicator flashes when you must define an area on the Edit Pad using the Edit Pen.
15	Enter Freehand Area	Use this feature to save a freehand area by touching with the Edit Pen .
16	Enter Freehand Area indicator	This indicator flashes when you have defined a freehand area on the Edit Pad. You must select Enter Freehand Area to save the freehand area(s).
17	Cancel Areas	Use this feature to cancel the defined area shape(s) for the selected Edit Number .

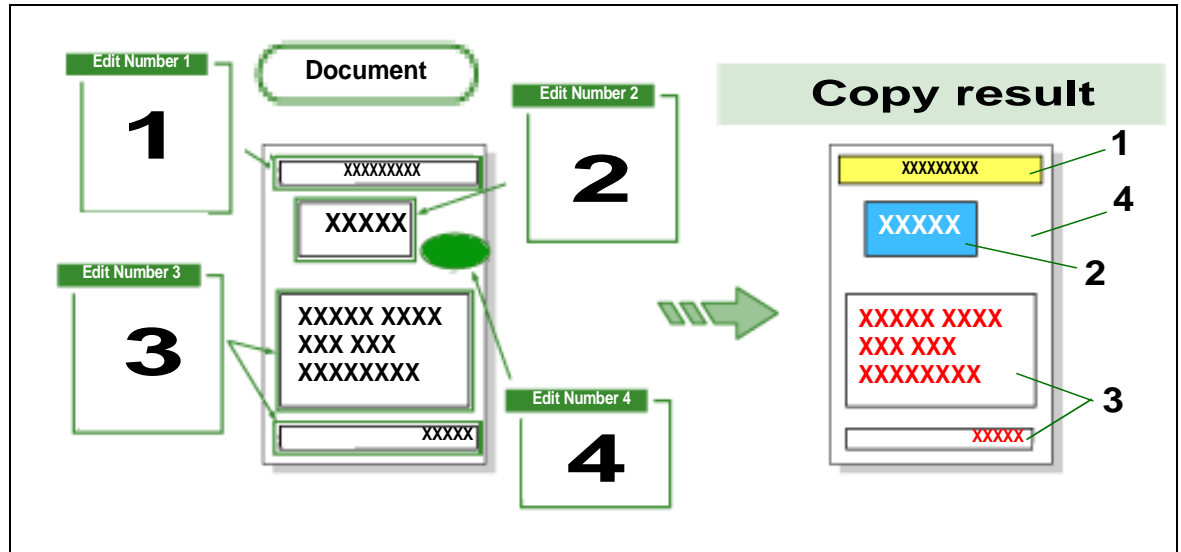
The following illustration defines the **Color Palette**, **Customer Palette**, and **Cancel Edit Number** features:



Call-out No.	Name	Function
18	Select Color indicator	Flashes to indicate a color should be selected from the Color Palette or Customer Palette.
19	Color Palette	You can select 27 individual colors from the Color Palette to add effect to your documents.
20	Customer Palette	You can select 18 colors from the Customer Palette to add effect to your documents. These colors can be altered to custom colors by the System Administrator through Tools Mode.
21	Cancel Edit Number	Touch with the Edit Pen to cancel all selections made for the selected Edit Number . A lighted arrow to the right of the Edit Number indicates the Edit Number you select.

An example of using the Edit Pad

The following illustration demonstrates the copy results after selecting four types of Edit Pad features for one document.



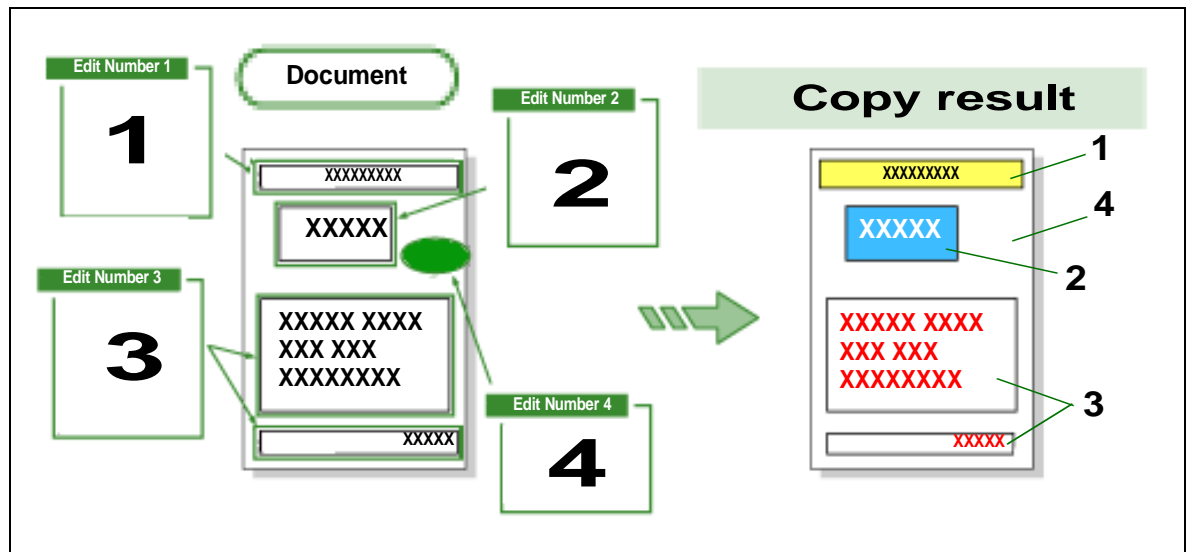
The following steps demonstrate how to accomplish the results in the illustration above.

1 Applying colors to the background:

- For **Edit Number 1**, use **Highlight** and **Point Whole Area**. Yellow was chosen from the Color Palette to highlight the rectangle.
- The copy result appears on the right side of the above illustration (1).

2 Applying colors to the background and convert the text:

- For **Edit Number 2**, use **Negative Image** and **Point Whole Area**. Blue was chosen from the Color Palette to highlight the rectangle and the text was changed from black to white.
- The copy result appears on the right side of the above illustration (2).



3 Applying colors to the text:

- For **Edit Number 3**, select **Color Conversion** and **Point Whole Area**. Red was chosen from the Color Palette to highlight the text.
- The copy result appears on the right side of the above illustration (3).

4 Erasing or deleting an area:

- For **Edit Number 4**, select **Erase Inside** and **Freehand**. The area was first marked with the Freehand feature, and then the oval shape was deleted.
- The copy result appears on the right side of the above illustration (4).

3. Basic Edit Pad Procedure

Overview

This chapter tells you how to select and combine the Edit Pad features. Also included is a basic Edit Pad procedure you can use to edit your original documents. Copier/printer features that cannot be used with the Edit Pad are listed in this section.

KEY POINT: The Touch screen provides some instructions to assist you as you edit documents.

Basic procedure for using the Edit Pad

Use the following basic procedure to edit your documents using the Edit Pad.



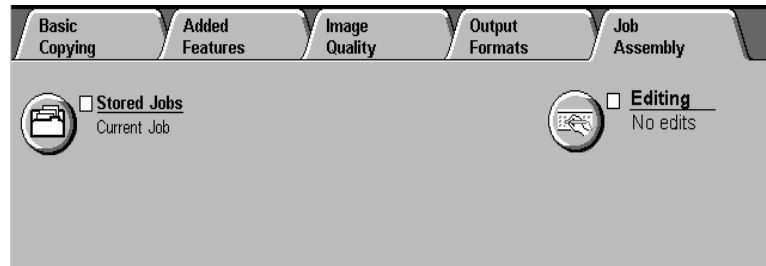
KEY POINT: Editing thick documents To edit books or thick documents, make a copy of the desired page or pages and use the copy for editing when using the Edit Pad. Use the original document (book or thick document) on the **Document Glass** to copy and print the edited copy.



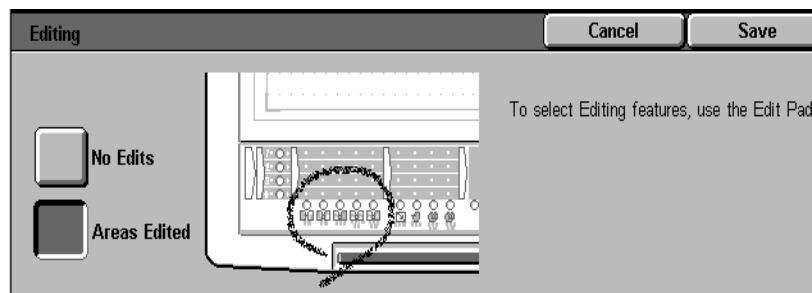

Features you cannot use with the Edit Pad

The following copier/printer features cannot be used in combination with the Edit Pad:

- You cannot use the document feeder (DADF) to make copies of documents that were edited with the Edit Pad. To make a copy, place the document on the **Document Glass**.
- When you use the Edit Pad features, you cannot use the **Original Orientation** feature for copying. You must position the document and the copy paper in the same orientation.
- The selections you make on the Edit Pad cannot be stored in the **Stored Jobs** feature.

NOTE: The **Stored Jobs** function appears to allow you to save an edit job, but your Edit Pad selections are **not** actually saved to a **Stored Jobs** program number.

- These additional features cannot be combined with the Edit Pad functions:
 - Book copying
 - Multiple Up
 - Transparency Separators
 - Mirror Image/Negative Image
 - Repeat Image
 - Stored Jobs programming
 - Mixed size originals
 - Covers
 - Poster Mode

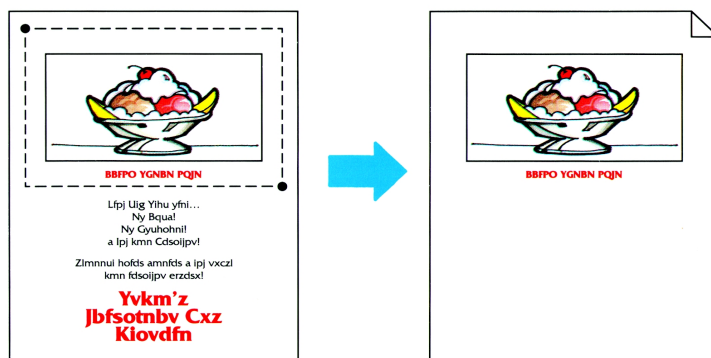

Erase Outside

The **Erase Outside** feature deletes the images outside of the selected area.

You can extract a selected area and make a copy. All areas on which **Erase Outside** are applied are deleted, regardless of the selection order of other **Edit Features**.



NOTE: For additional information on combining Edit Pad features and the Basic Edit Pad Procedures, see Chapter 3, "Basic Edit Pad Procedure."

KEY POINT: When the **Erase Outside** area and **Erase Inside** area overlap, **Erase Inside** has priority.

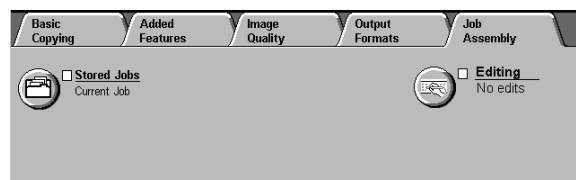

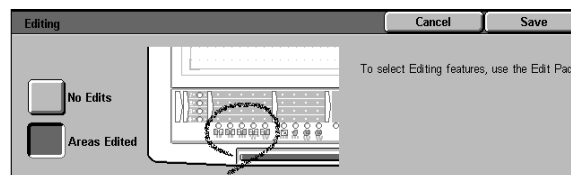

Erase Outside with Auto Center

Erase Outside can be used with the Auto Center feature on the copier/printer Control Panel by touching the **Added Features** tab. Next touch the **Margin Shift** option, then Side 1, and finally **Auto Center**.

When one **Erase Outside** area is selected, the specified area is shifted to the center.

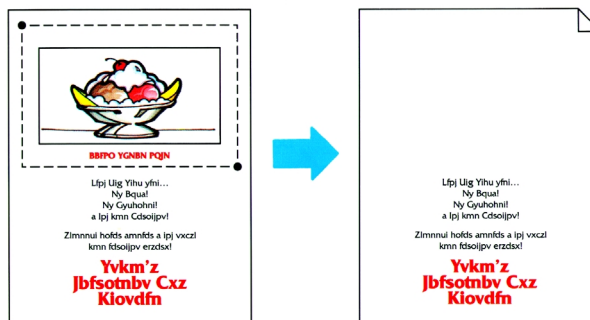


NOTE: The entire document shifts when you select other features, such as **Highlight**, on the same area.

When two or more **Erase Outside** areas are selected, the specified areas are deleted, but are not shifted to the center.

Erase Inside

The **Erase Inside** feature deletes the images inside the selected area.

5. Selecting an Area Shape

Overview

This chapter tells you how to define shapes for editing your document using the four Edit Pad Area Shapes: **Rectangle Area**, **Freehand**, **Point Outside Area**, and **Point Whole Area**.



KEY POINT: Only one feature can be used with each **Edit Number**.

KEY POINT: For more information about selecting a Feature or Color, refer to Chapter 4, "Selecting a Feature," and Chapter 6, "Selecting a Color."

You can select *only* one **Area Shape** for each **Edit Number**. However, you can define multiple areas of the same type.

Keep in mind the following **Area Shape** rules:



NOTE: You can define a maximum of 200 areas for each original document.

- You can make up to 4,000 points for each original document.
- An enclosed area can be no smaller than 3 mm in diameter or width.

Use the procedure on the following pages to define an **Area Shape**.

Defining an Area Shape



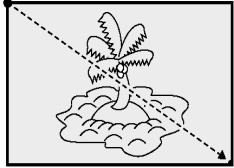


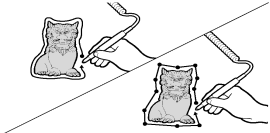





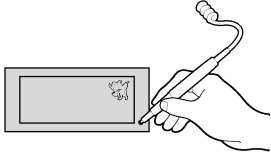
To define an **Area Shape**:

1. Lift the clear plastic overlay and place a document on the upper right corner of the **Edit Pad**.
2. Lower the overlay.
3. Touch the **Edit Pen** to the original to define the position and/or size of the area you want to edit. The spot you touch with the **Edit Pen** is sensed electronically by the **Edit Pad**.

Methods for defining a shape:

You can define the following shapes:

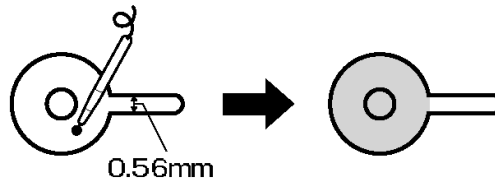
- Define a **Rectangle Area** by touching the **Edit Pen** to opposite corners of the shape.
- Define a **Freehand** area by drawing around the area with the **Edit Pen** or by making a series of points to define the shape.
- Define a **Point Outside Area** by pointing to a spot that is outside an enclosed area.
- Define a **Point Whole Area** by pointing to a spot within an enclosed area.

Using the Edit Pen

Keep in mind the following when using the **Edit Pen**:

- Always hold the **Edit Pen** perpendicular (straight up) to the **Edit Pad**. If you hold the pen at an angle, the point may not be entered correctly.
- An enclosed area can be no smaller than 3 mm in diameter or width.
- If you touch the **Edit Pen** to the document on the **Edit Pad** within 1 mm of a text character or image, the copier/printer may read the point as if it were part of the character or image.
- Lines closer than 0.56 mm are read as one line and the feature you select will not be applied to that area. Refer to the illustration below.

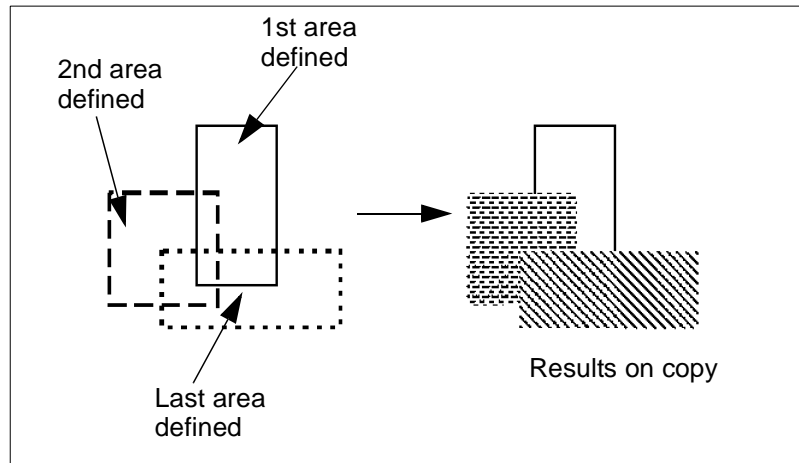


Overlapping areas

When you define two or more areas and they overlap each other, the options you select for the area you defined last are applied over the previous areas.

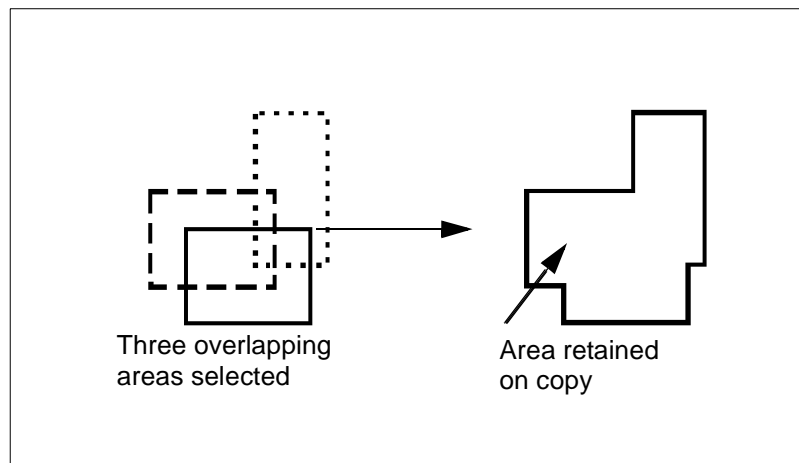
Priority of areas

This illustration shows the priority given when you define multiple areas.



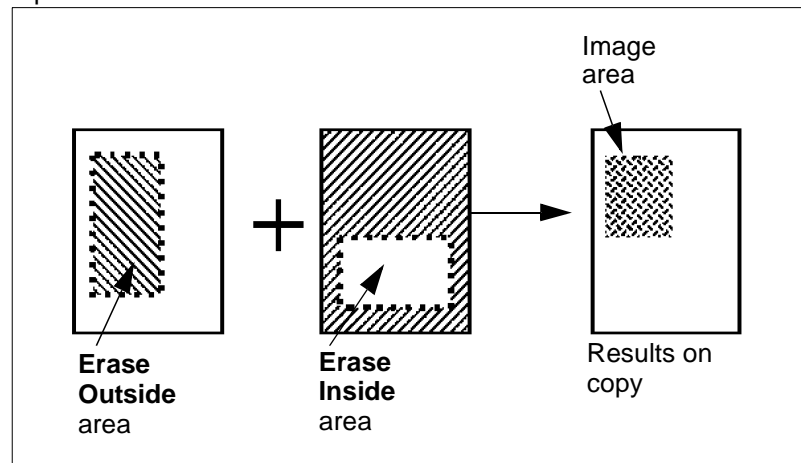
Erase Outside

This illustration shows the results on the copy when an **Erase Outside** area and an **Erase Inside** area overlap.



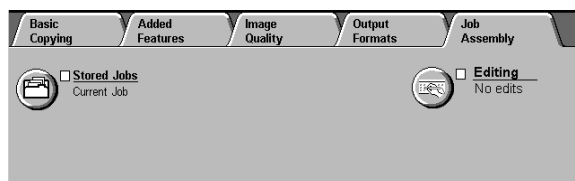

Dot method

Place a series of dots around the area to be defined. You must make a minimum of three dots. (You can make a maximum of 4,000.)

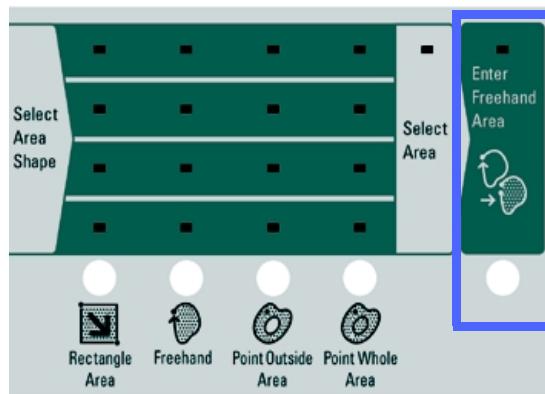


Dot Method



KEY POINT: Do not cross lines when using either the line method or the dot method, otherwise, the area will not be defined correctly.

- 8 Select **Enter Freehand Area** to save the defined area.



- A single tone indicates that the area has been saved.
- You can continue to enter more **Freehand** areas without selecting **Freehand Area** again. Simply use the **Edit Pad** and draw another **Freehand** shape on the original. You must select **Enter Freehand Area** after defining each shape.
- To cancel, select **Cancel Areas** after you have defined the area.

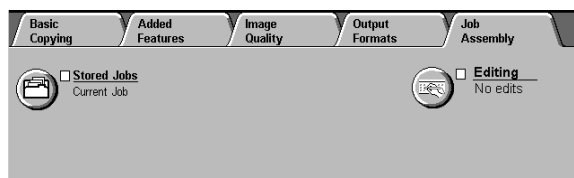

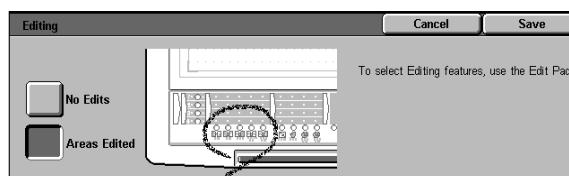

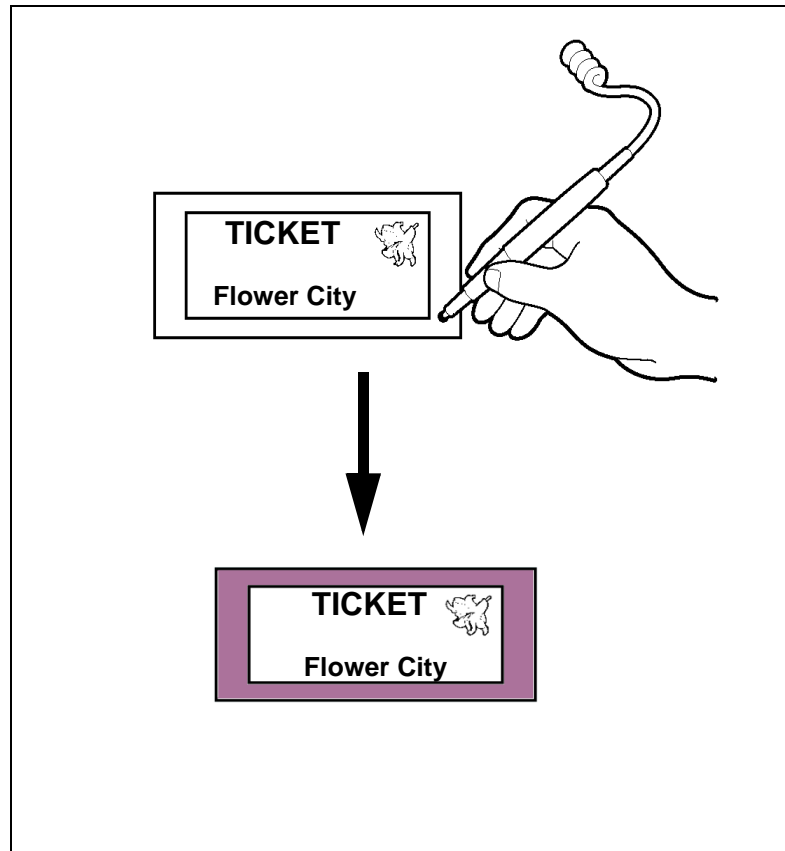

7 If you want to fill an outside area with color: With the **Edit Pen**, point to a spot on your original document that is outside an enclosed area.

If the area you point to is enclosed with a solid line, the enclosed area is colored. If the area is not enclosed with a solid line, the color fills to the edges of the copy and there is a white border on the copy.





- If there is a break in the line enclosing the inside area, or if the line is too thin, the inside area is colored the same as the outside area.
- If a point is placed in an area where a portion of the area has less than 0.5 mm between lines, the copier/printer is unable to recognize the area.
- A single tone indicates the area has been saved.
- You can continue to enter more point areas without selecting **Point Outside Area** again. Simply point to another area using the **Edit Pen**.
- To cancel, select **Cancel Areas** after you have defined the area.



NOTE: The defined area of the copy may reflect a 0.5 mm misregistration.

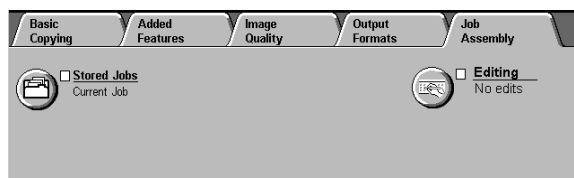

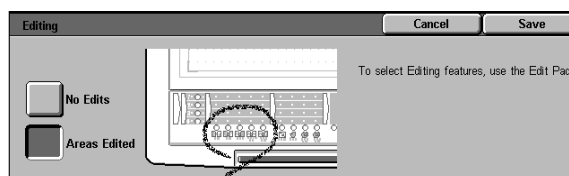

From the copier/printer Control Panel, touch **Editing** on the **Job Assembly** tab.

Touch **Areas Edited** on the **Editing** screen.

Place your original document face-up on the **Edit Pad** underneath the Clear Plastic Overlay.

4

Select an **Edit Number**. The **Edit Feature** indicators of the selected number flashes.

5

Select the **Edit Feature**. The available **Area Shapes** flash.

5

6 Select **Point Whole Area** with the **Edit Pen**.

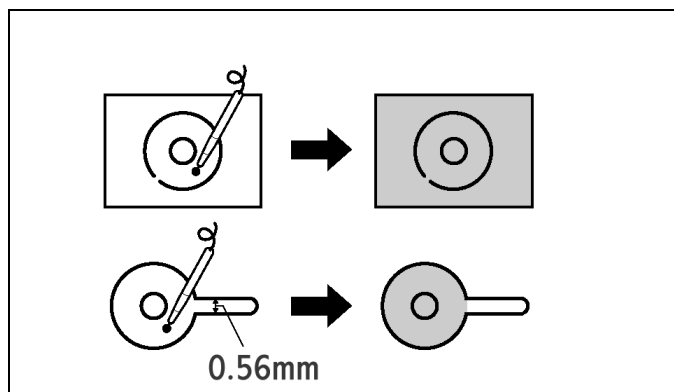
Use the Point Whole Area feature when you want to apply a color to the entire area within an enclosed frame. **Examples:** Pie charts and bar graphs.



To select a different **Area Shape**, select the desired **Area Shape**. The selected **Area Shape** lights.

7 Point to a spot on the original document that is inside an enclosed frame.

- Keep the point away from the line of the frame.
- If the frame line is broken or two lines are too close together (less than 0.56 mm), the copier/printer is not able to recognize the frame.



- A single tone indicates the area has been saved.
- You can continue to enter more areas without selecting **Point Whole Area** again. Simply point to another area using the **Edit Pen**.
- To cancel, select **Cancel Areas** after you have defined the area.

NOTE: The defined area of the copy may reflect a 0.5 mm misregistration.



8 Select a color from the **Color Palette**.



You can apply only one color to the areas defined for each **Edit Number**. To select a different color, select the new color with the **Edit Pen**.

9 When you are finished editing the original, remove it from the **Edit Pad** and place it face down in the top left corner of the **Document Glass**.

10 If you wish to choose other features, touch **Save** on the copier/printer Touch screen. Select any other desired features (**Reduce/Enlarge**, **Paper Tray**, etc.) and enter the desired number of copies.

If you enlarge the defined area, you can enlarge the area to fit on paper no bigger than 11 x 17 inches (A3).

11 Press the **Start** button to make copies.

6. Selecting a Color

Overview

The Color Palette is divided into two sections. The left side of the Color Palette consists of 27 individual colors. The 18 colors in the Customer Palette on the right side can be registered in the Tools Mode (as described in chapter 7) as 18 different colors or remain at the factory default of six colors of three densities each.

When you make a color selection, all colors on the palette are valid choices, whether they appear on the Customer Palette or on the Color Palette.

If the colors in the **Customer Palette** are changed, a new palette can be printed and inserted under the **Edit Pad Control Panel** cover.



KEY POINT: You can select any color from the **Color Palette** when using the **Highlight**, **Color Conversion**, and **Negative Image** features.



NOTE: Only one feature can be used with each **Edit Number**.

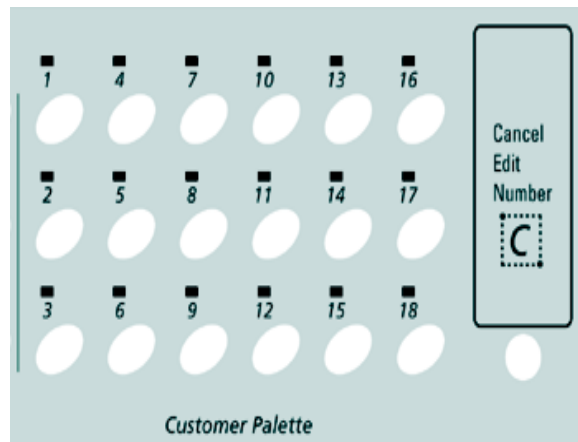


KEY POINT: For more information about selecting a Feature or an Area Shape, refer to the Chapter 4, “Selecting a Feature,” or Chapter 5, “Selecting an Area Shape.”

Customer Palette

The default settings for the Customer Palette provides six columns of colors with three rows. One row contains high density colors, the second medium density colors and the third row contains low density colors.

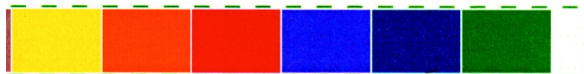
For example, the default settings show one column containing yellow at 3 levels of density.



NOTE: Once you alter the default settings, the density levels of each row change.

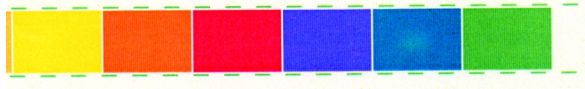
High Density Colors

High density colors are suitable for text or lines or for the background when inverting text (**Color Conversion, Negative Image**).



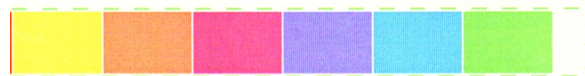
Medium Density Colors

Medium density colors are suitable for graphs or illustrations. **(Highlight)**



Low Density Colors

Low density colors are suitable for background of text or lines and can also be used as light colors. **(Highlight)**



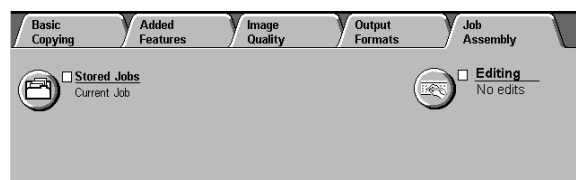

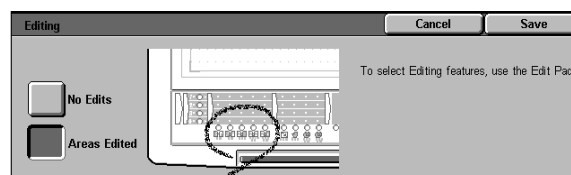

- 2 Touch **Areas Edited** on the **Editing** screen.



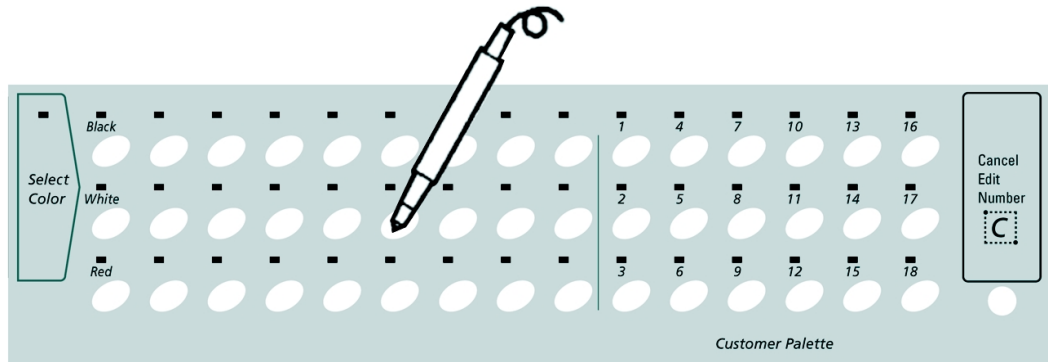

9 If you wish to choose other features, touch **Save** on the copier/printer Touch screen. Select any other desired features (**Reduce/Enlarge**, **Paper Tray**, etc.) and enter the desired number of copies.

If you enlarge the defined area, you can enlarge the area to fit on paper no bigger than 11 x 17 inches (A3).

10 Press the **Start** button to make copies.

Selecting a single color (Output Color)

When using the **Basic Copying, Output Color** feature, you can select a single color from the **Edit Pad Color Palette**. Use the following procedure when selecting a single color from the **Basic Copying, Output Color** screen.



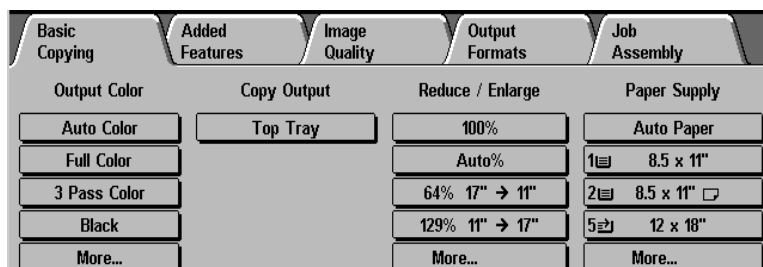

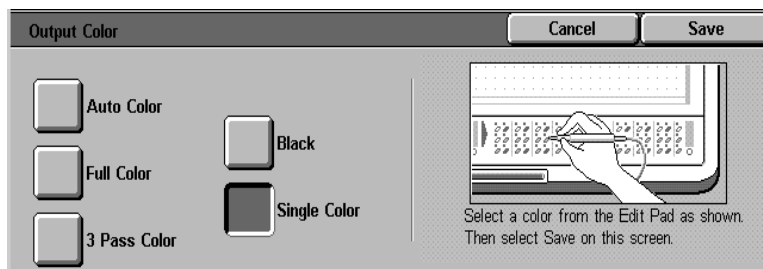
KEY POINT: The single Color option may be used with other Edit Pad features to change the background of an edited original to a single color.

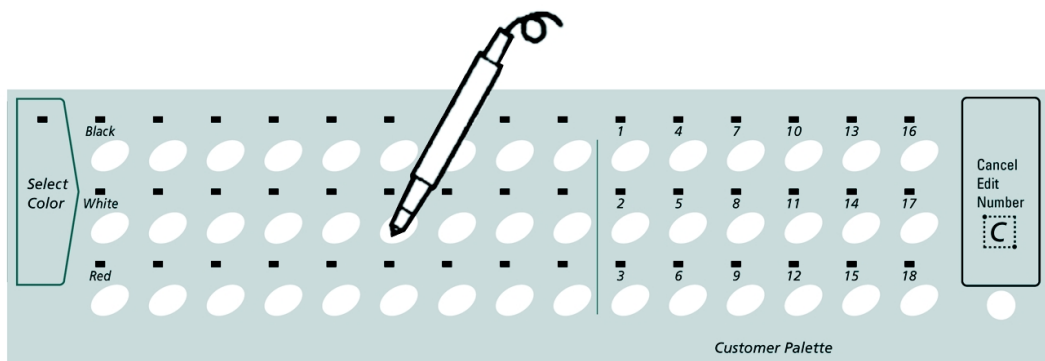

3 Select a color with the **Edit Pen**.



- The **Select Color** indicator flashes to indicate when a color should be selected.
- To select a different color, select the new color with the **Edit Pen**.

4 Select any other desired features (**Reduce/Enlarge**, **Paper Tray**, etc.) and enter the desired number of copies.

If you enlarge the defined area, you can enlarge the area to fit on paper no bigger than 11 x 17 inches (A3).

5 Press the **Start** button to make copies.

7. Cancelling Selections

Overview

This chapter tells you how to cancel features, shapes or color selections you make on the Edit Pad.

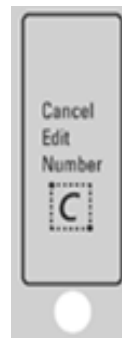
Making Cancellations and Changes

You can cancel or correct a selected area, feature, or color.

When you select an **Edit Number**, the indicator flashes, and you can correct or cancel the selected area, feature or color.

Cancelling Edit Number settings

To cancel the features after you define the area, select **Cancel Edit Number** on the right side of the **Edit Pad Control Panel**. The feature and Edit Number are canceled. If you desire a new **Edit Number** or feature, then select an **Edit Number** and a feature.



Changing an area

Select **Cancel Areas** to cancel all the areas you defined for the same Edit Number. Change the area on the **Edit Pad**. However, you cannot change the area selection method.



Changing a color

Select the color you desire.

Cancelling all settings

- Select **No Edits** on the **Touch** screen to cancel all the selected settings.

NOTE: When **Job Completion Timeout** is set, the selected features are reset automatically after a fixed time. The Timeout features can be adjusted in Tools Mode. For more information refer to Chapter 8, System Administration Functions.



Cancelling and redefining an area

Key Procedure

- 1 Select the **Edit Number** to be corrected. The **Edit Number** indicator flashes.
- 2 For a selected **Edit Number**, you can either cancel the selection or reprogram the selections.

Correcting or cancelling an area:

1. Select **Cancel Areas** and the defined area is cancelled.
2. Redefine the area.

NOTE: You can not change the **Area Shape** at this point. To change the **Area Shape**, cancel the setting with **Cancel Edit Number** and select again.



8. System Administration Functions

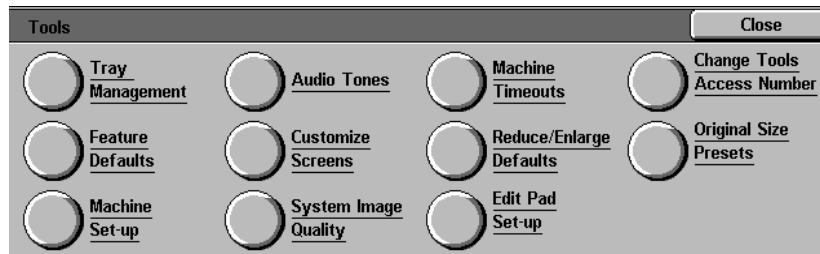


Figure 1: Tools screen

Overview

When the Edit Pad is installed, the Custom Palette Set-up and Print Palette features are available in Tools Mode. These options which you can access by touching the **Edit Pad Set-up** button, are set by the Administrator. A password is required to enter Tools mode to change the settings.

Custom Palette Setup

If the color you want to use is not available on the **Color Palette**, change the **Custom Palette Set-up** to register the desired color. The System Administrator may print the **Custom Palette** and place it on the **Edit Pad** to allow you to select colors from the new palette.



Print Palette

The **Print Palette** option prints a three page palette of registered colors. You may place these sample colors on the **Edit Pad** so you can review and select them while editing.



Using Tools Mode

To change Edit Pad default settings you must have the Administrator password and enter Tools Mode. The procedures for entering and exiting Tools Mode are described here.

Entering Tools Mode

KEY POINT: All previous programming selections are canceled when you press the **Clear All** button in the Tools Mode.

KEY POINT: You cannot program jobs while in the Tools Mode.

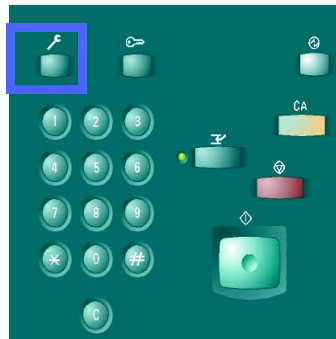


Figure 2: Control Panel and Administration button

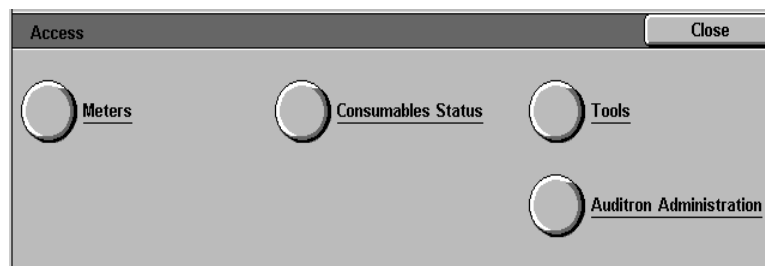


Figure 3: Access screen

Press the **Administration** button on the **Control Panel**, found in Figure 2, to display the **Access** screen, illustrated in Figure 3.

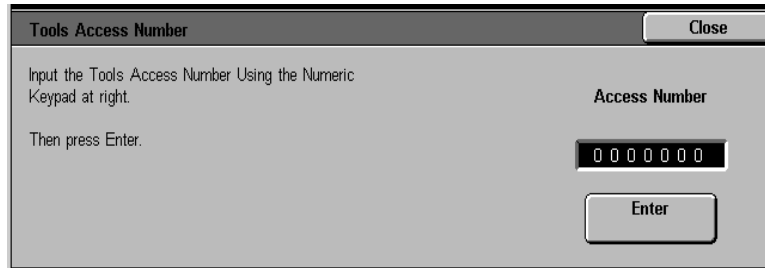


Figure 4: Tools Access Number screen

- 2 Touch the **Tools** button to display the **Tools Access Number** screen, as illustrated in Figure 4.

If you make a mistake, press the **C** button to clear your selections. Touch **Cancel** to end the operation and display the Tools screen.

- 3 Use the numeric keypad to enter the correct password and touch **Enter** on the Touch Screen.



NOTE: For further information on accessing Tools mode, see the copier/printer System Administration Guide, Chapter 3. See the System Administrator if you require help.

To close the window without entering a password, touch **Close**.

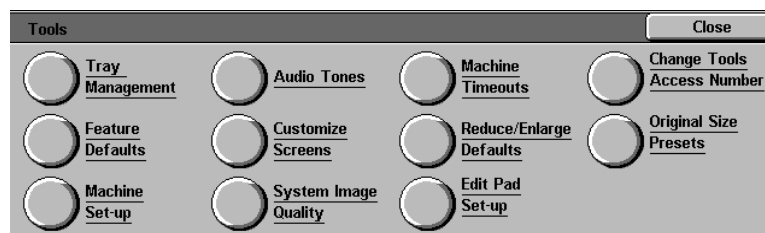


Figure 5: Tools screen

After you have entered the correct password, the Tools screen displays, as illustrated in Figure 5.

Customer Palette

You may change the colors of the Customer Palette colors from their factory defaults. You may change any of the eighteen Customer Palette settings if the color you wish to use is not available.



NOTE: Only those knowledgeable regarding color management should change the **Customer Palette** percentages. Changing the percentages of one color will affect the printed output of the copy.

NOTE: The default **Customer Palette** colors are listed later in this section.

Follow these steps to change the **Customer Palette colors to their default settings.**

Enter Tools Mode by following steps 1-3 from the Entering Tools Mode section.

The Tools screen is shown in Figure 6.

NOTE: See the System Administrator if you require help accessing Tools mode.

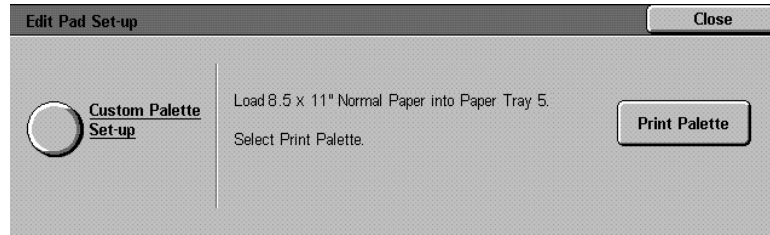


Figure 7: Edit Pad Set-up screen

- 2 Touch the **Edit Pad Set-up** button to display the **Edit Pad Set-up** screen (Figure 7).

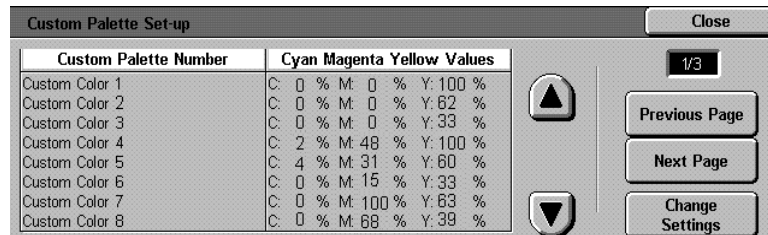


Figure 8: Custom Palette Set-up screen

- 3 Touch the **Custom Palette Set-up** button to display the **Custom Palette Set-up** screen (Figure 8).

The first of three pages of **Custom Palette** settings are listed. Use the **up** and **down** arrows or the **Next Page** and **Previous Page** buttons to move to the **Custom Color** settings you want to change.

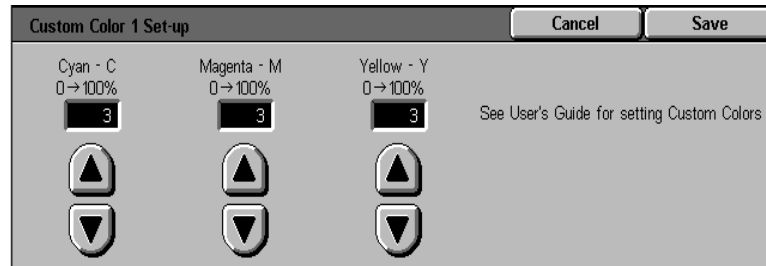


Figure 9: Custom Color Set-up screen

- 4 Touch the **Change Settings** button to edit the settings for the selected **Custom Palette Number**. The **Custom Color Setup** screen for that color is shown.(Figure 9) The Title bar lists the Custom Color Set-up number that you are changing.

Define the color contents of Cyan, Magenta, and Yellow by using the **up** and **down** arrows. You can set the percentages of each color from 0 to 100. Changing the percentage of one color affects the printed output of the other colors.

- 5 Touch **Save** to confirm the new **Custom Color** settings. Touch **Cancel** to exit without saving your changes.
- 6 Repeat steps 4 and 5 if you wish to change the color content of other colors after selecting the correct **Custom Palette Number**.

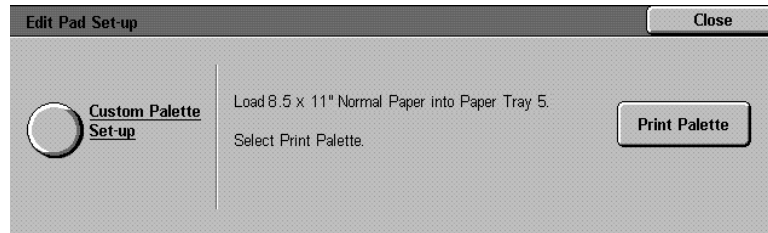


Figure 10: Edit Pad Set-up screen

- 7 From the **Edit Pad Set-up** screen (Figure 10) touch **Print Palette** to print the color palette of the registered colors.

You must place 3 sheets of 8.5" x 11" or A4 paper in Paper Tray 5 before touching the **Print Palette** button. The **Print Palette** pages are printed from Tray 5.

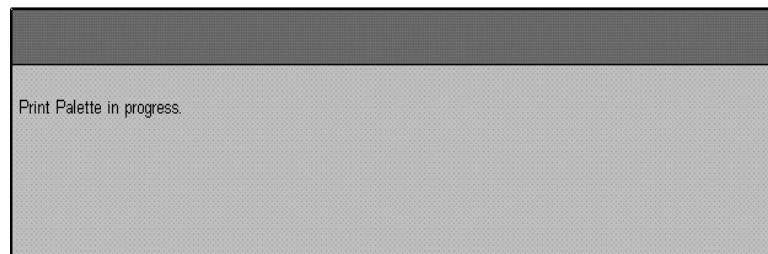


Figure 11: Printing message screen

The printing in process message appears in Figure 11 as shown.

One copy of each **Color Palette** is printed in order. The printed copies can be trimmed and pasted on to the **Color Palette** of the **Edit Pad** to be used as samples.



NOTE: The **Customer Palette** default settings contain three rows of colors. One row contains high density colors, the second medium density colors and the third row contains low density colors. For example, at the default settings you see one column containing yellow at the three levels of density. Once you alter the default settings, the density of each row changes.

8

Touch **Close** to exit the **Edit Pad Set-up** screen.

8

Exiting Tools Mode

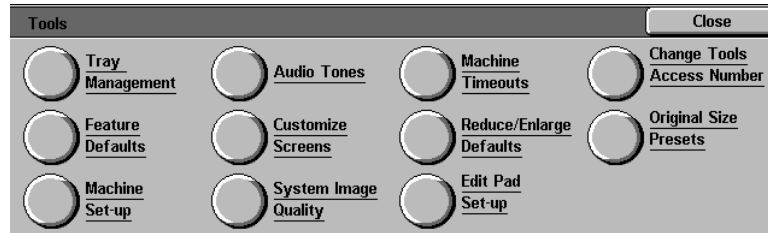


Figure 12: Tools screen

To exit the Tools Mode, touch the **Close** button on the Tools screen (Figure 12).

KEY POINT: Touch **Close** to exit any screen within Tools Mode without making changes and to display the previous screen.

Default Customer Palette Color Content

The default settings for the Customer Palette provides six columns of colors with three rows (Table 1.) One row contains high density colors, the second medium density colors and the third row contains low density colors. If you alter the settings and then wish to change back to the default settings, change the correct **Custom Palette Number** using the **Custom Color Setup** screen.

9. Editing Tips And Problem-Solving

Overview

This section contains tips and problem-solving techniques to help you use the Edit Pad features effectively.

Application Tips

The application tips described here will help you to use the Edit Pad features effectively. You will learn about:

- Applying colors to graphs and charts
- Defining shapes to apply colors to text
- Applying colors to areas difficult to define or to small areas
- Enlarging part of a document and copying it in the center of a page

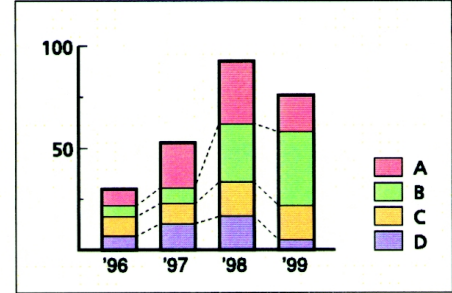
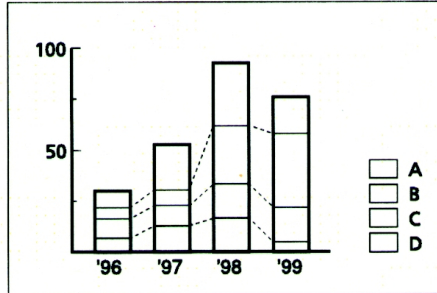

Applying colors to graphs and charts

Use the **Highlight** feature to apply colors to bar graphs and charts on which you have defined **Point Whole Area**.



NOTE: The line width on an original document must be well-defined to ensure the selected areas are highlighted.



Key Procedures

1 When applying colors to bar graphs and charts, use **Point Whole Area** to define the areas within the boundaries.

1. Select **Highlight**, then select **Point Whole Area**.
2. Mark a point within the bars or the chart to define the area.
3. Select a color from the **Color Palette**.

2 To apply another color, select another Edit Number, then select **Highlight**.

1. Select another **Edit Number**.
2. Apply **Highlight** as in Step 1.



KEY POINT: When you define areas with the Edit Pen, point at blank areas as far away from text or boundaries as possible.

KEY POINT: It is better to define the areas with boundaries using **Point Whole Areas**. If you use **Rectangle Area** or **Freehand**, the position of the copied area may differ slightly from the original area.

NOTE: A misregistration of 0.5 mm of the defined area on the copy is possible.



Defining and applying colors to text

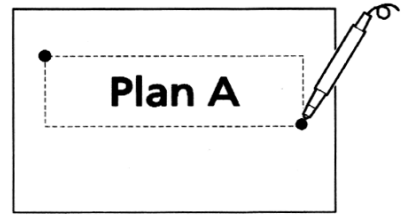
Various methods for selecting Area Shapes

When applying colors to text, use the **Color Conversion** feature. You can change the color of the text or images within the defined boundaries to one specified color. Choose the **Area Shape** suited to the document.

Key Procedures

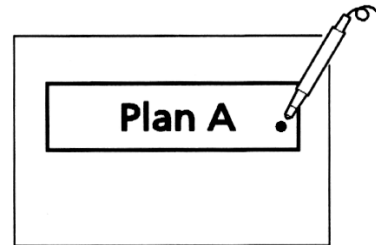
When applying colors to text that is not enclosed within boundaries, you must define the Area Shape with **Rectangle Area**.

1. Select **Highlight**, then select **Rectangle Area**.
2. To define the area, mark two points diagonally with the text enclosed.
3. Select a color from the **Color Palette**.



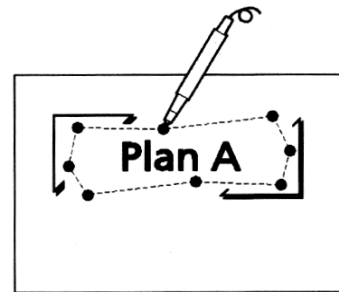
When applying colors to text that is enclosed within a boundary, you must define **Area Shape** with **Point Whole Area**.

1. Select **Highlight**, then select **Point Whole Area**.
2. To define the area, mark one point within the boundary.
3. Select a color from the **Color Palette**.



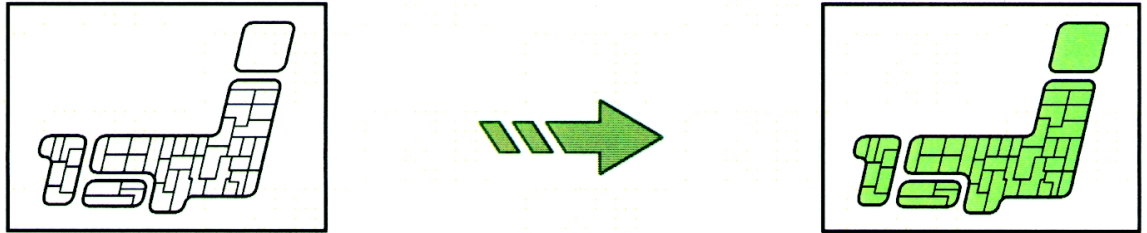
When applying colors to text with images nearby, you must define **Area Shape** with **Freehand**.

1. Select **Highlight**, then select **Freehand**.
2. To define the area, mark multiple points that enclose the text.
3. Select a color from the **Color Palette**.



Applying colors to areas difficult to define

When applying colors to areas that are difficult to define or are small (such as maps), first apply colors to the whole document, then apply white or the desired color to the areas outside.



Key Procedure

- 1 When applying colors to the whole area (in this case the map), you must define the whole area with **Rectangle Area** so that the map is included. Then apply **Highlight** to the whole area.

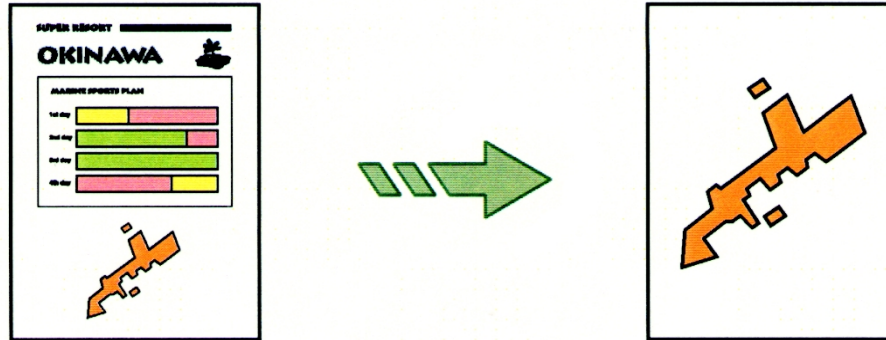
1. Select **Highlight**, then select **Rectangle Area**.
2. To define the area, mark two points so that the whole difficult to define area is enclosed.
3. Select a color from the **Color Palette**.

- 2 Without touching the map, use **Point Outside Area** to apply white to the outside areas only.

1. Select another **Edit Number**.
2. Select **Highlight**, then select **Point Outside Area**.
3. To define the area, mark a point on the area surrounding the difficult to define area.
4. Select a color from the **Color Palette**.

Enlarging and centering an area of a document

To enlarge and center an area of a document, select **Auto Center** for copy position, and enlarge the area for copying. The **Auto Center** option is found on the **Added Features** tab under **Margin Shift**.



Key Procedure

- 1 Extract the necessary area by selecting **Erase Outside**, then define the area with **Rectangle Area**.
 1. Select **Erase Outside**, then select **Rectangle Area**.
 2. To define the area, mark two points so that the area is enclosed.
- 2 Select **Margin Shift** from the **Added Features** screen. Then **Auto Center** for the copy position.
- 3 Enlarge the extracted area by selecting the **Reduce/Enlarge** percentage on the **Basic Copying** screen.



KEY POINT: You can obtain various edit results by using a combination of features.

Copy the extracted area using a document type suitable to the area. For example, select **Map** for **Original Type** on the **Image Quality** screen.

Problem-Solving

Occasionally you may experience unexpected results.



NOTE: This section discusses problems you may experience when you have not applied highlighting correctly.

Colors are not applied to all areas

Parts of the text or small areas may not reflect highlighting even though **Highlight** is applied for all areas. In this case, apply colors to the small areas defined with **Rectangle Area**, then apply colors to the areas within the boundary defined with **Point Whole Area**. All the parts will be colored.

Reason for problems

If the outline of an area is 0.5 mm of space or less, the **Edit Pad** recognizes the lines as overlapping lines instead of a boundary. Therefore, even if **Point Whole Area** is selected, the area will not be colored.

Key Procedure

1 Use **Highlight** on areas (parts surrounded by approximately 0.5 mm of space or less) where colors are missing. Select **Highlight**, then define the area with **Rectangle Area**.

1. Select **Highlight**, then select **Rectangle Area**.
2. Mark two points so that the text with a width of 0.5 mm of space or less is enclosed, then define the area.
3. Select a color from the **Color Palette**.

2 Apply the same color to the whole area. Using **Highlight** again, the output will have no missing colored areas. You must select **Highlight**, then mark a point within the boundary defined with **Point Whole Area**.

1. Select another edit number.
2. Select **Highlight**, then select **Point Whole Area**.
3. Mark a point inside the document, then define the area.
4. Select the **Color Palette** color you selected in Step 1.

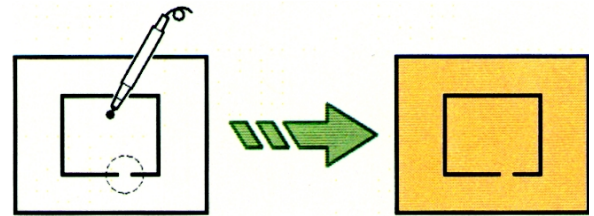
Colors applied to areas not defined

If colors are applied to areas you have not defined, it may be a result of how you mark a point on the document or of how you define the area.

Problem: When colors are incorrectly applied to the whole area

Reason: The line defining the boundary may be broken or too thin.

Corrective Action: To correct this problem, join the line or make it thicker.

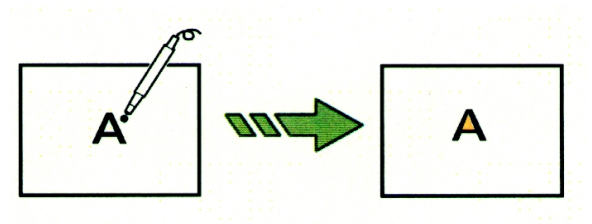


Problem: When **Highlight** is selected for an area within the boundary but only part of the text is colored

Reason: The point you marked may be too close to the text or the document may be out of position on the document glass.

Corrective Action: Correct this problem by:

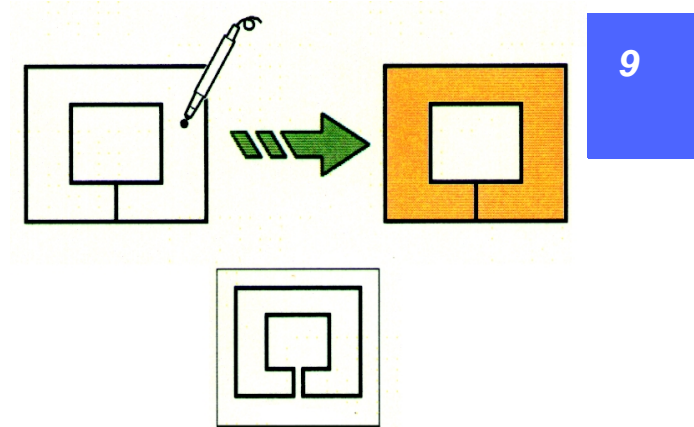
- Pointing at the blank areas away from text or boundaries when marking a point with the Edit Pen.
- Properly placing the document on the document glass.



Problem: When color is applied to the whole area within the boundary but only a part is supposed to be colored

Reason: As the lines of the inner and outer rectangle are connected, the areas are detected. When the text is very close to the outer boundary, the text may be detected as being connected to the boundary.

Corrective Action: Define the inner area with **Point Whole Area**.
