Preamble

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Library General Public License, applies to some specially designated Free Software Foundation software, and to other libraries whose authors who decide to use it. You can use it for your libraries too.

When we speak of free software, we are referring to freedom, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish), that you receive source code or can get it if you want it, that you can change the software or use pieces of it in new free programs; and that you know you can do these things.

3.4. Application of Additional Terms.

3.4. Copyright, Patent and Trademarks. The Licensed Software contains material that is protected by copyright laws and trademark laws, and by international treaty provisions. The Licensed Software has U.S. Patents Pending. All rights not granted to Licensee by this Agreement are expressly reserved by Matrox. Licensee shall not remove any proprietary notice of Matrox from any copy of the Licensed Software. Licensee shall reproduce and include the copyright, trademark, or other restrictive and proprietary notices and markings from the original on all copies of the Licensed Software.

4. Support and Maintenance.

4.1. General Obligations. Subject to Licensee's registration of Licensed Software and payment of the annual support and maintenance fee, Matrox will provide Licensee with:

A. Access to support groups, including, without limitation, the developer's forum web site to read and post messages approved by the moderator;
