

Printing to a Creo Color Server from a Windows Vista Client Workstation

General

This document describes how to print from a Windows® Vista® client workstation to a Creo color server.

To print from a Vista client workstation to a Creo color server, you **must** turn the UAC (User Account Control) off.

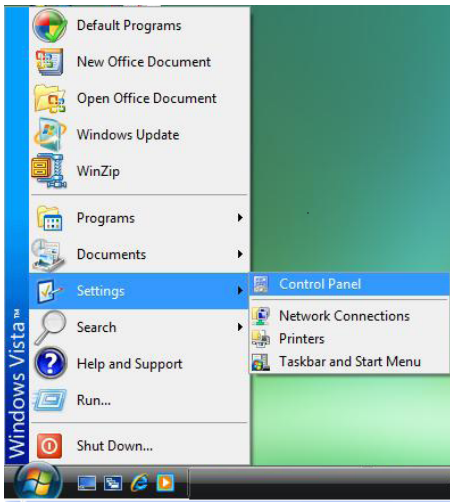

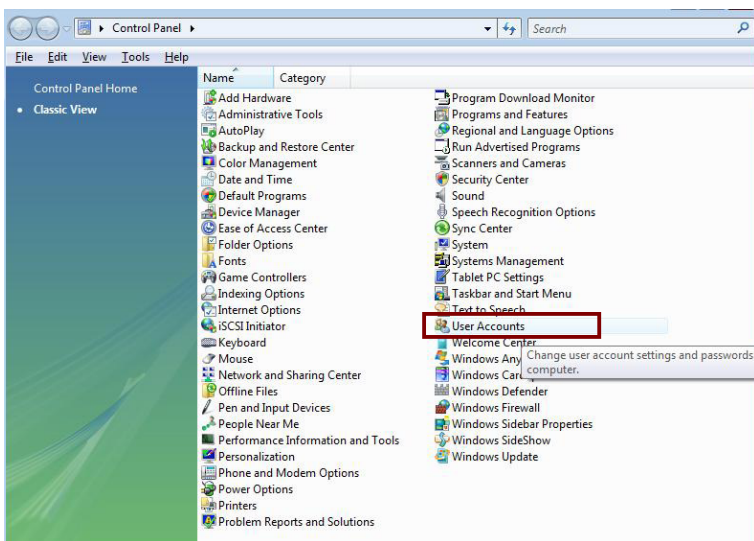
Turning off User Account Control

Note: To perform the following procedure, you must be able to log on with or provide the credentials of a member of your local **Administrators** group.

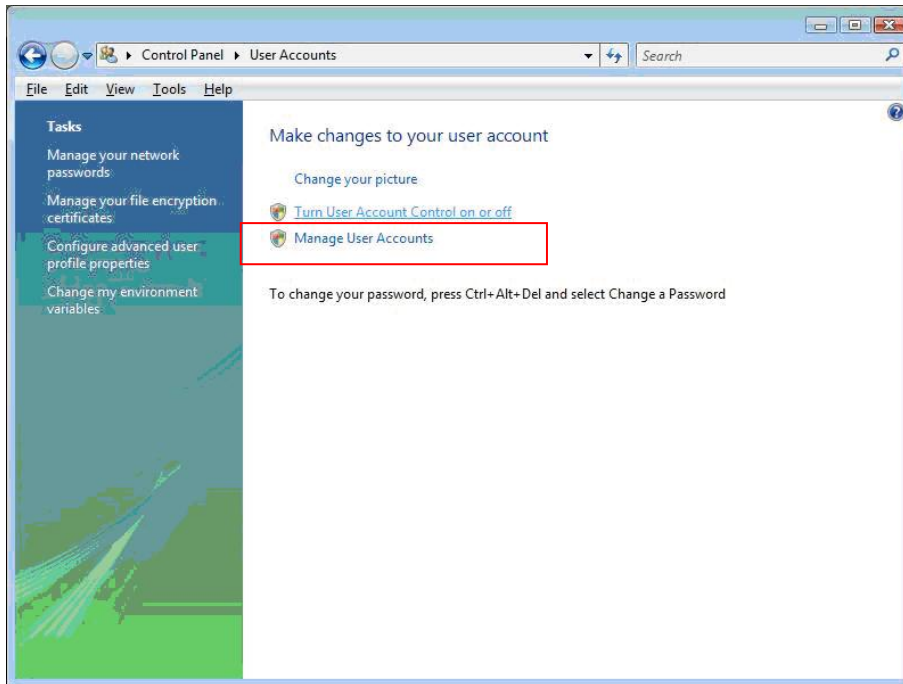
1. On your desktop click **Start**, and then select **Settings > Control Panel**.



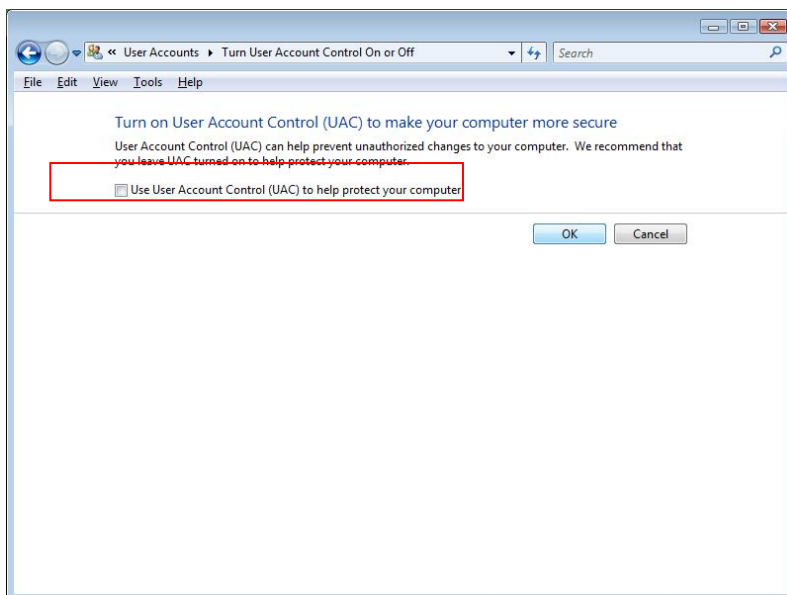
2. In the Control Panel window, select **User Accounts**.



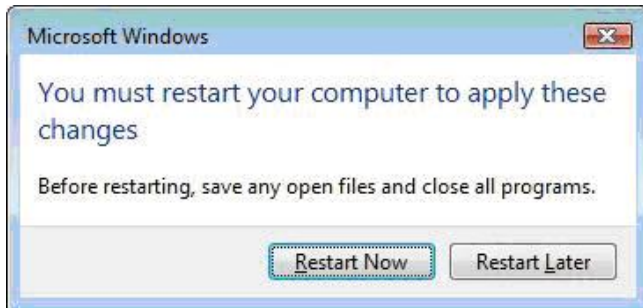
3. In the User Accounts window, select **Turn User Account Control on or off**.



4. If the **User Account Control** message appears, click **Continue**.
5. Clear the **Use User Account Control (UAC) to help protect your computer** check box, and then click **OK**.



6. Click **Restart Now** to apply the change right away.
